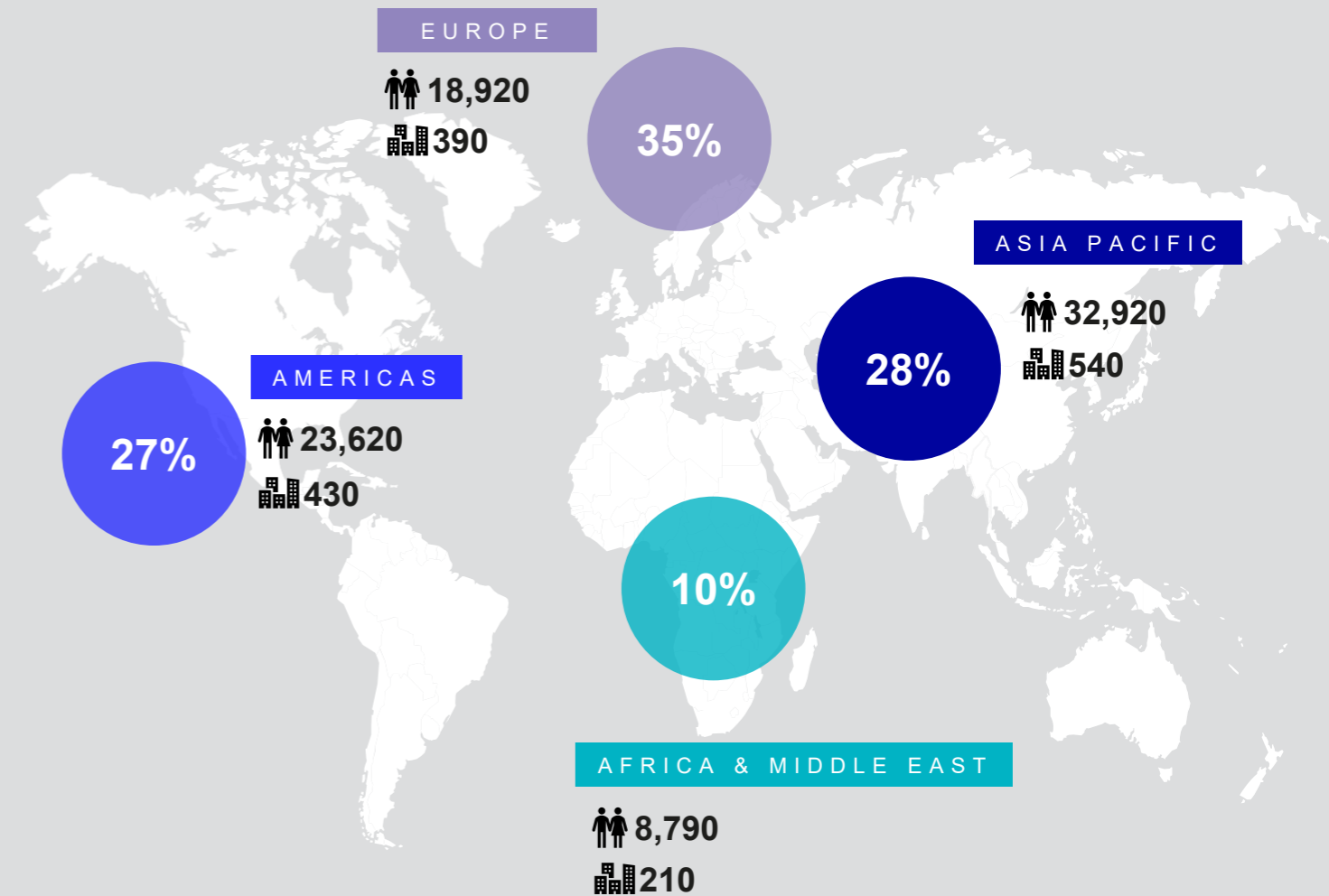

REVENUE & WORKFORCE BREAKDOWN

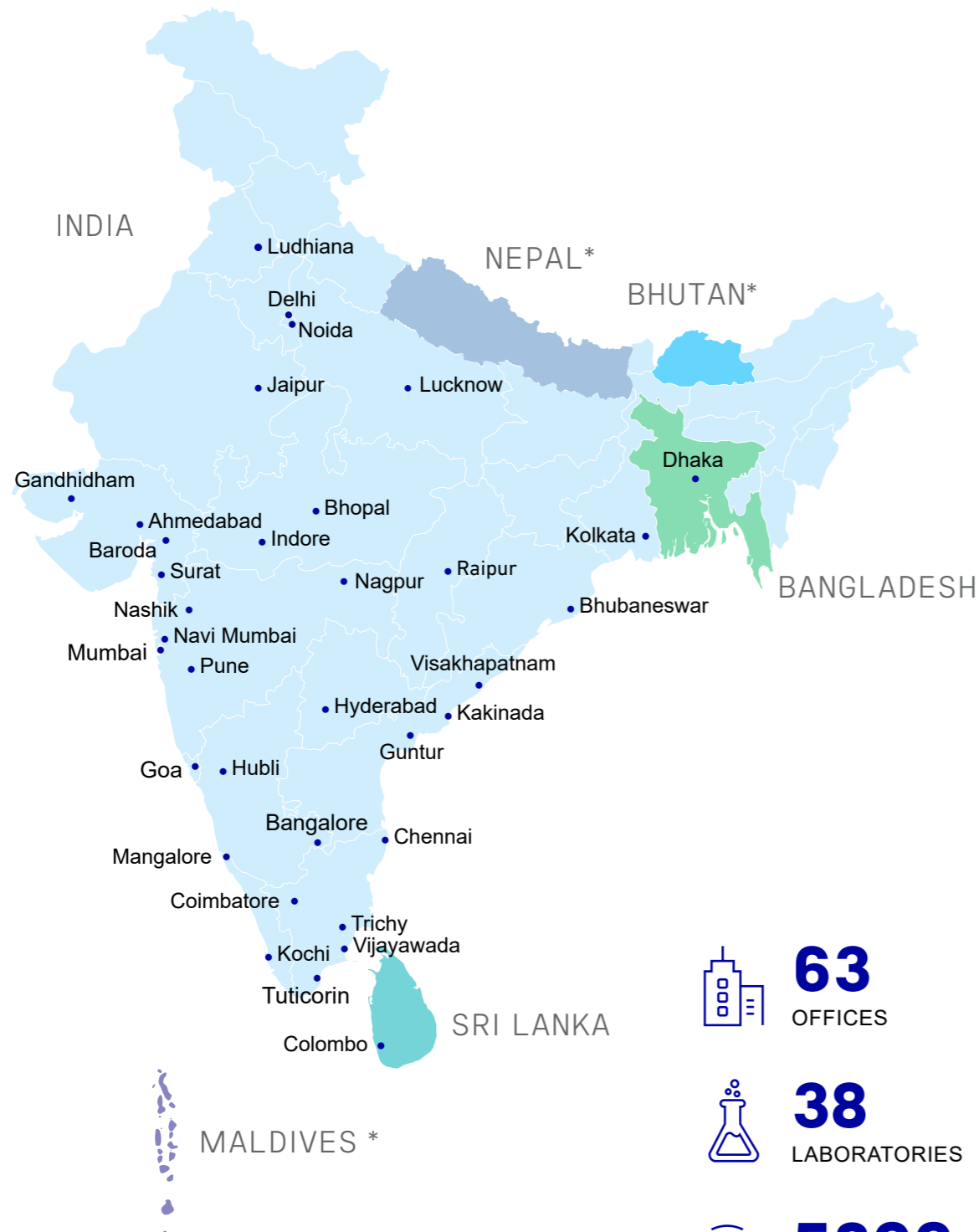


By geography, as of December 31, 2024

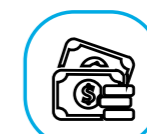
